**REQUEST FOR EXPRESSION OF INTEREST FOR
ARCHITECTURAL AND DETAILED ENGINEERING DESIGN AND
CONSULTANCY SERVICES FOR THE CONSTRUCTION OF
SCIENCE RESEARCH FACILITY, PHASE 1**

1. The *Philippine Science High School-Central Mindanao Campus*, through the *General Appropriation Act for FY 2018 (RA No. 10964)* intends to apply the sum of One Million Nine Hundred Thirty Nine Thousand One Hundred Fourteen Pesos & 00/100 (Php 1,939,114.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CMC CONS 18-01-002. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Philippine Science High School-Central Mindanao Campus* now calls for the submission of eligibility documents for *the preparation of design, drafting the plans and the detailed estimates for the construction of 3-storey reinforced concrete. Elliptical-oval shaped building with wind breakers that support the components of a green and SMART building. The said building will house the following:*

Ground Floor

- Information, looby and visitor's holding area
- Display area and/or museum
- Office (good for 5 personnel)
- One-pantry
- Comfort rooms (male and female) and for disabled/elderly person
- Utility room

Second Floor

- Robotics lab
- Simulation lab
- Air lab
- Water lab
- Soil lab
- Materials science lab
- Comfort rooms (male and female)

Third Floor

- AVR and function room
- Science garden and showroom
- Interactive room
- Comfort rooms (male and female)

The said building will be located in the central part of the campus with an allowable foot print of 30-meters x 30 meters.

Interested consultants must submit their eligibility documents on or before *January 31, 2018, 11:00AM* at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.

3. The BAC shall draw up the short list of consultants from those who have submitted *Expression of Interest* and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective consultants who will be entitled to submit bids. The criteria and rating system for short listing are:
 - Applicable experience of the consultant – 30%
 - Qualification of personnel who be assigned – 30%
 - Current workload relative to capacity – 40%
 - Passing rate – 80%
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)* procedure. The Procuring Entity shall apply the weights of seventy percent (70%) for the Technical Proposals and thirty percent (30%) for the Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
6. The contract shall be completed within *sixty (60) calendar days*.
7. The Eligibility Screening form will be available at PSHS-CMC in Nangka, Baloi, Lanao del Norte upon payment of non-refundable amount of One Thousand Five Hundred Pesos only (P1,500.00) to the PSHS-CMC Cashier.
8. Bid documents will be available only to eligible bidders upon payment of non-refundable amount of Five Hundred Pesos & 00/100 (P500.00) to the PSHS-CMC Cashier.
9. The *Philippine Science High School-Central Mindanao Campus* reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
