Invitation to Bid for the Construction of Student's Concrete Kiosk

1. The *Philippine Science High School-Central Mindanao Campus*, through the *General Appropriation Act for CY 2018 (R.A. No. 10964)* intends to apply the sum of *Two Million Three Hundred Fourteen Thousand Pesos & 00/100 (P2,314,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CMC INFRA 18-05-010*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Science High School-Central Mindanao Campus* now invites bids for the following: construction of a one-storey open-sided building in a slopping ground with a combination of steel and polycarbonate roofing;

Completion of the Works is required in *one hundred twenty (120) calendar days*. The prospective bidder must have completed an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Philippine Science High School-Central Mindanao Campus and inspect the Bidding Documents at the address given below from *8:00am to 4:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders May 17-June 11, 2018 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Two Thousand Five Hundred Pesos (P2,500.00)*, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The *Philippine Science High School-Central Mindanao Campus* will hold a Pre-Bid Conference on May 28, 2018 11:00AM at *School Canteen, Philippine Science High School-Central Mindanao Campus*, which shall be opened only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before June 11, 2018, 9:00AM at *Philippine Science High School-Central Mindanao Campus*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened on June 11, 2018, @ 9:01 AM in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. *Bidders' representatives who choose to attend in the Bid opening must secure authorization letter from their construction firm.*
8. The *Philippine Science High School-Central Mindanao Campus* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
