



Invitation to Bid for the Rehabilitation of School Buildings (Design and Build Scheme)

1. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS**, through the *National Expenditure Program FY 2020* intends to apply the sum of Nineteen Million Six Hundred Thousand Pesos Only (Php 19,600,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **CMC INFRA 19-11-014**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS** now invites bids to rehabilitate the utility facilities of PSHS-CMC School Buildings by installation and replacement of the Fire Protection systems, centralized electrical systems, and installation of emergency public alarm system.

Completion of the Works is required in two hundred forty (240) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Philippine Science High School – Central Mindanao Campus and inspect the Bidding Documents at the address given below during 8am to 5pm only.

A complete set of Bidding Documents may be acquired by interested Bidders on November 28 – December 18, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Thousand Pesos Only and 00/100 (P20,000.00) to the PSHS-CMC Cashier.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Philippine Science High School-Central Mindanao Campus will hold a Pre-Bid Conference on December 6, 2019, 1PM at Philippine Science High School-Central Mindanao Campus, Nangka, Balo-i, Lanao del Norte, which shall be open to prospective bidders.


7. Bids must be duly received by the BAC Secretariat at the address below on or before December 18, 2019, 1:00PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 18, 2019, 1:01PM at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Science High School-Central Mindanao Campus reserves the right to reject any bid and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
