



## **Invitation to Bid for the Completion of Academic Building I (Re-Bidding)**

1. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS**, through the *National Expenditure Program FY 2020* intends to apply the sum of *Four Million Eight Hundred Fifty Thousand Pesos & 00/100 (Php 4,850,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for **CMC INFRA 19-12-017**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS** now invites bids for the completion of its Academic Building I by expanding and renovating the Library Unit with a gross floor area of 470 square meter to cater the needs of scholars and personnel to have an inviting, relaxing and conducive to learning library services.

Completion of the Works is required in one hundred eighty (180) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Philippine Science High School – Central Mindanao Campus and inspect the Bidding Documents at the address given below during 8am to 5pm only.
5. A complete set of Bidding Documents may be acquired by interested Bidders on December 9-January 2, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only and 00/100 (P5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Philippine Science High School-Central Mindanao Campus will hold a Pre-Bid Conference on December 16, 2019, 9AM (PST) at Philippine Science High School-Central Mindanao Campus, Nangka, Balo-i, Lanao del Norte, which shall be open to prospective bidders.


7. Bids must be duly received by the BAC Secretariat at the address below on or before January 2, 2020, 1:00PM (PST). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on January 2, 2020, 1:01PM (PST) at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Science High School-Central Mindanao Campus reserves the right to reject any bid and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
