WHEREAS, the PHILIPPINE SCIENCE HIGH SCHOOL - CENTRAL MINDANAO CAMPUS (PSHS-CMC) advertised the Request for Expression of Interest for the Architectural And Detailed Engineering Design And Consultancy For The Upgrading And Repair Of Administration Building in the PhilGEPS website, PSHS- CMC website, and a conspicuous place in the premises of the Philippine Science High School – Central Mindanao Campus continuously for 7 days;

WHEREAS, the Approved Budget for the Contract (ABC) is Nine Hundred Thirty Two Thousand Four Hundred Fifty Eight Pesos & 00/100 (Php 932,458.00) through General Appropriation Act for FY 2017 (RA No. 10924);

WHEREAS, among the contents of the Request for Expression of Interest is the announcement that the evaluation procedure to be adopted in the Quality-Cost Based Evaluation with assigned weights for technical and financial proposal as stipulated in approved BAC Res No. 2017-01-012A;

WHEREAS, in response to the said advertisements, only (1) consultant purchased eligibility documents;

WHEREAS, only one (1) consultant submitted their eligibility documents during the eligibility checking on February 9, 2017 and subsequently found to be eligible in the name of RD Galua Associates;

WHEREAS, in accordance with Section 24 of the Implementing Rules and Regulations of the Government Procurement Reform Act, shortlisting among the eligible consultants was conducted on February 10, 2017;

WHEREAS, as stipulated in BAC Res No. 2017-02-019 RD Galua declared in making up the shortlist for the said project;

WHEREAS, on February 14, 2017 RD Galua was notified about the shortlisting result and subsequently posted in PhilGeps and in the campus website;

WHEREAS, as stipulated in BAC Res No. 2017-03-032B RD Galua Associates found to be complying in the opening of technical and financial proposal conducted on March 6, 2017;

WHEREAS, as stipulated in BAC Res No. 2017-03-032B RD Galua Associates the Lone Bidder having the Highest Rated Bid with the score of 94.4%;

WHEREAS, the consultant was notified about the result of the bid evaluation and subsequently posted in the PhilGeps and PSHS-CMC websites as stipulated in Section 33.2.3 of the IRR of RA 9184;

WHEREAS, rdGalua Associates with the Highest Rated Bid has been invited to negotiate on March 14, 2017, and had passed the negotiations successfully;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by rdGalua Associates with Highest Rated Bid, it is found to have been responsive to all the requirements during the conduct of post qualification process on March 16, 2017;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare **RDGALUA ASSOCIATES** as the Bidder with the Highest Rated and Responsive Bid for the Architectural And Detailed Engineering Design And Consultancy For The Upgrading And Repair Of Administration Building;
- b) To recommend for approval by the Campus Director of the PSHS-CMC and for the approval of the higher authority the foregoing findings.
