KNOW ALL MEN BY THESE PRESENTS:

By Virtue of Management Committee Resolution No. 2017-06-015 this **CONTRACT**, (hereinafter called the Contract) is made and entered into this 10th day of July 2017 by and between:

PHILIPPINE SCIENCE HIGH SCHOOL – CENTRAL MINDANAO CAMPUS (PSHS-CMC), with postal address at Nangka, Balo-i, Lanao del Norte represented in this act by its Campus Director, **LORVI B. PAGOROGON**, and hereinafter referred to as the **OWNER**;

-and-

BRIMA CONSTRUCTION AND ENTERPRISES with principal address at 0054 Oxford Street, Celdran Village, Tubod, Iligan City and represented in this act by its General Manager/Proprietor, **SULTAN BAGUAN M. MAMISCAL**, hereinafter referred to as the **CONTRACTOR**;

WITNESSETH:

WHEREAS, PSHS-CMC advertised the Invitation to Bid for the **CONSTRUCTION OF CHEMICAL WASTE DISPOSAL SYSTEM** in the Philippine Government Electronic Procurement System (PhilGEPS) website, CMC website, and a conspicuous place at the premises of PSHS-CMC continuously for seven (7) days;

WHEREAS, in response to the said advertisements, only one (1) contractor submitted a letter of intent and purchased bid documents;

WHEREAS, in the scheduled Pre-bid conference on May 31, 2017 at 1:00 PM, there was only one (1) contractor who attended the conference;

WHEREAS, on the bid submission deadline at 1:00 PM on June 13, 2017, only one (1) bid was received;

WHEREAS, **BRIMA CONSTRUCTION AND ENTERPRISES** was determined as the bidder with the Lowest Calculated Bid as read;

WHEREAS, after bid evaluation, the **CONTRACTOR** was notified on the results of evaluation, as the bidder with the Lowest Calculated Bid as Calculated, post-

The CONTRACTOR shall prepare a tarpaulin signboard and must be suitably framed for outdoor display at the project location, and shall be posted as soon as the award has been made, please see Attachment 1.

ARTICLE 19

GENERAL PROVISIONS

Supplementary Use of Contract Documents. The bid documents shall be supplementary to this Contract. In case of conflict between the Bid Documents and the Contract, the later shall prevail, unless it is very evident that the former is correct. Any and all deficiencies in the provisions of this Contract intended to be covered hereby or otherwise connected with or related to the Project covered hereby, but not expressly covered by the provisions of this Contract shall be supplied by the Pertinent Provisions of the Bid/tendered documents and shall be binding for purposes of this Agreement.


Compliance with Law Ordinances etc. The CONTRACTOR shall comply with all the laws ordinances and regulations of both the national and local government applicable to or binding upon the parties hereto, the works covered by this Agreement, or the persons engaged on the performance and accomplishment of the works covered by this Agreement and shall be totally responsible for all damages either to the OWNER or to the government, national or local, for the non-observance of such laws, ordinances and regulations.

Modification. No modification including transfer or assignment or sub contracting of any right or obligation under the terms of this agreement shall be valid unless mutually agreed upon in writing by the parties herein.


Punch List. There shall be only one (1) Jointly Agreed Punch List. It shall be jointly conducted fifteen (15) calendar days before the last day of completion period.
