WHEREAS, the Approved Budget for the Contract (ABC) is One Million Nine Hundred Fifty Thousand Pesos &00/100 (Php 1,950,000.00);

WHEREAS, in response to the said advertisements, there were four (4) suppliers who submitted letters of intent and purchased bid documents;

WHEREAS, in the scheduled Pre-Bid Conference on June 15, 2017 @ 9:00AM there were two (2) suppliers attended the said conference;

WHEREAS, on the bid submission deadline at 9AM on June 27, 2017, four (2) bids were received;





- b) **LABTRADERS, INC.,** as a Bidder with the **Lowest Calculated and Responsive Bid** for the **Supply, Delivery and Commissioning of Laboratory Tools and Equipment Equipment (Items 1 and 2 only)** in the amount of **TWO HUNDRED ONE THOUSAND THREE HUNDRED FIFTY PESOS & 00/100 ONLY (Php 201,350.00)**;
- c) **YANA CHEMODITIES, INC,** as a Bidder with the **Lowest Calculated and Responsive Bid** for the **Supply, Delivery and Commissioning of Laboratory Tools and Equipment Equipment (Items 4 and 9 only)** in the amount of **ONE HUNDRED TWENTY THREE THOUSAND FOUR HUNDRED EIGHTH PESOS & 00/100 ONLY (Php 123,480.00)**;
- d) **Failure of Bidding for Items No. 4, 5, 6, 7, and 8,** re-bidding as a next mode of procurement;
- e) To recommend for approval by the proper authority of the PSHS Central Mindanao Campus for the foregoing findings.


