## **Invitation to Bid for the Completion Of Road Network/ Site Development, Phase 4 (Re-Bidding)**

1. The *Philippine Science High School-Central Mindanao Campus*, through the *General Appropriation Act for FY 2016 (R.A. No. 10717) Continuing Appropriation* intends to apply the sum of *Six Million Six Hundred Ninety Six Thousand One Hundred Seventy One Pesos & 89/100 (Php 6,696,171.89)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CMC INFRA 17-09-017*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Science High School-Central Mindanao Campus* now invites bids for the construction of concrete road at the south side of the campus; this road will make accessible the Chemical storage building, water pump house, gen set area, warehouse building and Gate 2. This will include traffic, directional and building signage. Open parking lots will also be constructed; the campus landmark will be developed. A concrete wall will be constructed parallel to the barangay road to widen the football area. Landscaping will be improved by planting shrubs, etc. at the entrance gate and other areas within the campus.

Completion of the Works is required *in one hundred twenty (120) calendar days*. The prospective bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Philippine Science High School-Central Mindanao Campus and inspect the Bidding Documents at the address given below from *8:00am to 4:00pm (Philippine Standard Time)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting September 26- October 16, 2017 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Seven Thousand Pesos (P7,000.00)*, pursuant to the latest Guidelines issued by the GPPB.

*It may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids .

The *Philippine Science High School-Central Mindanao Campus* will hold a Pre-Bid Conference on October 4, 2017, 11:00AM at *Admin Building, Philippine Science High School-Central Mindanao Campus*, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before October 16, 2017, *11:00AM (PST)* at *Philippine Science High School-Central Mindanao Campus*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened on October 16, 2017, @ 11:01 AM (PST) in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. *Bidders' representatives who choose to attend in the Bid opening must secure authorization letter from their construction firm.*
8. The *Philippine Science High School-Central Mindanao Campus* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
