## **Invitation to Bid for the Completion of Multi-Purpose Gymnasium Phase 3**

1. The *Philippine Science High School-Central Mindanao Campus*, through the *General Appropriation Act for CY 2016 (R.A. No. 10717)* intends to apply the sum of *Nine Million Four Hundred Thousand Five Hundred Eighty Five Pesos & 69/100 (P9,400,585.69)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CMC INFRA 16-05-002*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Science High School-Central Mindanao Campus* now invites bids for the continuation of the previous un-completed components of the gymnasium. The works shall include but not limited to contruction and finishing of; offices, bleachers, canopies, slab on grade, stairs, comfort rooms, windows, doors, electrical, plumbing, tiling, electrical & plumbing fixtures and other finishing works as per drawings and contract;

Completion of the Works is required *in one hundred fifty (150) calendar days*. The prospective bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, that contractors under Small A and Small B catagories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty percent (50%) of the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Philippine Science High School-Central Mindanao Campus and inspect the Bidding Documents at the address given below from *8:00am to 4:00pm*.

5. A complete set of Bidding Documents may be acquired by interested Bidders May 19-June 7, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Nine Thousand Pesos (P9,000.00)*, pursuant to the latest Guidelines issued by the GPPB.

*It may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids .

The *Philippine Science High School-Central Mindanao Campus* will hold a Pre-Bid Conference on May 26, 2016 9:00AM at *OCD Boardroom, Philippine Science High School-Central Mindanao Campus*, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before June 7, 2016, *10:00AM* at *Philippine Science High School-Central Mindanao Campus*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. *Bidders' representatives who choose to attend in the Bid opening must secure authorization letter from their construction firm.*
8. The *Philippine Science High School-Central Mindanao Campus* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
