



INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF MINI-BUS (RE-BIDDING)

1. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS**, through the *General Appropriation Act for FY 2018 (RA No. 10964)* intends to apply the amount of Four Million Five Hundred Ten Thousand Pesos & 00/100 (PhP 4,510,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **CMC GOODS 18-07-017**. Bids received in excess of the ABC for each item shall be automatically rejected at bid opening.
2. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS** now invites bids for procurement of mini-bus or coaster with the following specifications:
 - 30-seater
 - High roof
 - Engine: 4-cylinder in-line, 16-valve OHV, gear drive, diesel
 - Displacement: at least 4100cc
 - Maximum power output: 134Hp/3000rpm
 - Maximum torque: 360Nm/1600rpm
 - Regulation: euro 4 compliant
 - Fuel system: In-line type
 - Transmission: 5-speed manual
 - Chassis: double wishbone
 - Front suspension, leaf spring, rigid
 - Rear suspension, with stabilizers (RR), recirculating ball, power steering system
 - Tires & wheels: 700R1612PR (12) 5.5OF Steel
 - Cooling System: Manual Air
 - Conditioning: with Roof Ventilator
 - Cool air intake: schnorkel type (with precleaner)
 - Audio & video systems: AM/FM/CD 4-speaker
 - Mic and Amplifier: standard mic with amplifier
 - Accessories: roof Mount TV/Monitor 15.6" Full HD w/ USB multimedia player support
 - Bus CCTV system Full HD dashboard camera w/ DVR
 - Backing camera & sensor
 - Exterior features: 4 round semi-shield lamps
 - Auto folding type center door (w/ buzzer, warning lamp) with luggage and back door
 - Rear window defogger with timer w/ rear wiper
 - High mount stop lamp
 - Interior features: with seat under tray, baggage rack, sunvisor, room lamp, step lamp, luggage lamp, curtain, fabric seat material and floor carpet & mat

- Safety: high security key cylinder
- Anti-theft system
- With fire extinguisher
- Seatbelts
- Other functions: w/ meter illumination control
- Digital clock

Delivery of the Goods is required ninety (90) calendar days upon receipt of the Purchase Order. Bidders should have completed a single contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the National Statistics Office (NSO) consumer price indices, must be at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. The award is per item basis.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Philippine Science High School – Central Mindanao Campus and inspect the Bidding Documents at the address given below during 8am to 4pm only.

A complete set of Bidding Documents may be purchased by interested Bidders from July 27-August 3, 2018 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos Only and 00/100 (P5,000.00) to the PSHS-CMC Cashier.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Philippine Science High School-Central Mindanao Campus will hold a Pre-Bid Conference on August 6, 2018, 9AM (PST) @ Philippine Science High School-Central Mindanao Campus, Nangka, Baloi, Lanao del Norte, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before August 20, 2018, 2:00PM (PST). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on August 20, 2018, 2:01PM (PST) at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below provided that they will submit an authorization letter signed by the bidder. Late bids shall not be accepted.

8. The Philippine Science High School-Central Mindanao Campus reserves the right to reject any bid and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
