INVITATION TO BID FOR THE SECURITY MANPOWER SERVICES FOR CY 2017

1. The **PHILIPPINE SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS**, through the *National Expenditure Program for CY 2017* intends to apply the amount of *Two Million One Hundred Sixty Three Thousand Two Hundred Eighty Two Pesos & 00/100 (PhP 2,163,282.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for **CMC GOODS 16-08-003**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 2. The **SCIENCE HIGH SCHOOL-CENTRAL MINDANAO CAMPUS** now invites bids from any security agency that can provide a minimum of eleven (11) security guards, which composed of nine (9) male and two (2) female guards, to be rotated on a 8-hour working schedule at three (3) working shifts.
 3. The contract duration for the security manpower services covered from January 1, 2017 to December 31, 2017. The security agency must be duly licensed, registered, and a member of PADPAO with proper operating permits and other statutory requirements. It must have been engaged in the business for at least three (3) years and the clients being served for the last three (3) years is at least three (3) procuring entities. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. Interested bidders may obtain further information from Philippine Science High School – Central Mindanao Campus and inspect the Bidding Documents at the address given below during 8am to 4pm only.

A complete set of Bidding Documents may be purchased by interested Bidders on August 26-September 19, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos Only and 00/100 (P5,000.00) to the PSHS-CMC Cashier.

6. The Philippine Science High School-Central Mindanao Campus will hold a Pre-Bid Conference on September 5, 8AM @ Philippine Science High School-Central Mindanao Campus, Nangka, Baloi, Lanao del Norte.
7. Bids must be delivered to the address below on or before September 19, 2016, 10:00AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB .

Bid opening shall be on September 19, 2016, 10:01AM at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below provided that they will submit an authorization letter signed by the bidder. Late bids shall not be accepted.

8. The Philippine Science High School-Central Mindanao Campus reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
