



Invitation to Bid for the Implementation of K-12 Program (MITHI-ICT Infrastructure) (Design and Build Scheme)

1. The *Philippine Science High School-Central Mindanao Campus*, through the *National Expenditure Program for FY 2019* intends to apply the sum of *Six Million Seven Hundred Twenty Seven Thousand Pesos & 00/100 (P6,727,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CMC INFRA 19-02-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Science High School-Central Mindanao Campus* now invites bids for the following: to provide PSHS-CMC with a fiber optic backbone connecting all campus buildings, to include all necessary structured cabling to deliver (wired and wifi) network connectivity to all rooms and offices, IPPBx system, power backup system, and fault protection system;

Completion of the Works is required *in one hundred eighty (180) calendar days*. Bidders should have completed a contract similar to Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Philippine Science High School-Central Mindanao Campus and inspect the Bidding Documents at the address given below from *8:00am to 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on February 26-March 18, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Six Thousand Pesos (P6,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Philippine Science High School-Central Mindanao Campus* will hold a Pre-Bid Conference on March 6, 2019 1:00PM at Girls Dormitory, *Philippine Science High School-Central Mindanao Campus*, which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before March 18, 2019, 1:00PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on March 18, 2019, @ 1:01 PM at *Girls Dormitory, Philippine Science High School-Central Mindanao Campus*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. *Bidders' representatives who choose to attend in the Bid opening must secure authorization letter from their construction firm.*
9. The *Philippine Science High School-Central Mindanao Campus* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
