**REQUEST FOR EXPRESSION OF INTEREST
FOR CONSULTING SERVICES FOR THE ARCHITECTURAL
AND DETAILED ENGINEERING DESIGN FOR THE COMPLETION
OF MULTI-PURPOSE GYMNASIUM (RE-BIDDING)**

1. The *Philippine Science High School-Central Mindanao Campus*, through the *National Expenditure Program FY 2020* intends to apply the sum of One Million Two Hundred Fifty Thousand Pesos & 00/100 (Php 1,250,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CMC CONS 19-11-011. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Philippine Science High School-Central Mindanao Campus* now calls for the submission of eligibility documents for the architectural and detailed engineering design for the completion of Multi-Purpose Gymnasium project, which will be used as basis for preparing the Scope of Work and the Technical Specifications of the civil works. The project will be located in Nangka, Baloi, Lanao del Norte. PSHS-CMC envisions to have multi-purpose gymnasium which be used during school's various activities away from weather disturbance and major school programs likes graduation ceremony, foundation day, trainings and conferences and many others. This facility is a state-of-the-art yet economical, energy saving and environment friendly. With this, the PSHS-CMC intends to engage the technical and professional expertise of a consultant firm/company to undertake the following general architectural and detailed engineering works:
 - a. prepare and submit design standards in accordance with appropriate standards and accepted detailed engineering practice of PSHS System and the Department of Public Works and Highways (DPWH). Design standards for structures shall take into account, among other things, the seismicity of the area to determine the optimum safety of structures in the event of an earthquake.
 - b. prepare and conduct field surveys, investigation reports and seek queries of the end users desired design. These field investigations shall be carried out in accordance with the design guidelines, criteria and standards adopted by the PSHS System and the DPWH. All survey and investigation works shall be prepared in a manner satisfactory to carry out accurate design and production of plans.

Eligibility documents of interested consultants must be duly received by the BAC secretariat on or before *December 4, 2019, 9:00AM* at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

3. Interested bidders may obtain further information from *Philippine Science High School-Central Mindanao Campus* and inspect the Bidding Documents at the address given below during 8:00 am -5:00 pm.
4. A complete set of bidding documents may be acquired by interested bidders on November 26-December 4, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Two Hundred Pesos & 00/100 (Php 1,200.00) only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted *Expression of Interest, including the eligibility documents*, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:
 - Applicable experience of the consultant – 40%
 - Qualification of personnel who be assigned – 30%
 - Current workload relative to capacity – 30%
 - Passing rate – 80%
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)* procedure. The Procuring Entity shall apply the weights of seventy percent (70%) for the Technical Proposals and thirty percent (30%) for the Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
6. The contract shall be completed within *forty five (45) calendar days*.
7. The *Philippine Science High School-Central Mindanao Campus* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


