

Section V. Special Conditions of Contract

Notes on the Special Conditions of Contract

Similar to the Section III, Bid Data Sheet, the clauses in this Section are intended to assist the Procuring Entity in providing contract-specific information in relation to corresponding clauses in the GCC.

The provisions of this Section complement the GCC, specifying contractual requirements linked to the special circumstances of the Procuring Entity, the Procuring Entity's country, the sector, and the Works procured. In preparing this Section, the following aspects should be checked:

- (a) Information that complements provisions of Section IV. General Conditions of Contract must be incorporated.
- (b) Amendments and/or supplements to provisions of Section IV. General Conditions of Contract, as necessitated by the circumstances of the specific project, must also be incorporated.

However, no special condition which defeats or negates the general intent and purpose of the provisions of Section IV. General Conditions of Contract should be incorporated herein.

For foreign-assisted projects, the Special Conditions of Contract to be used is provided in Section X-Foreign-Assisted Projects.

1.17	<p>The Intended Completion Date is <i>September 1, 2020</i>.</p> <p>NOTE: <i>The contract duration shall be reckoned from the start date and not from contract effectivity date.</i></p>
1.22	The Procuring Entity is <i>Philippine Science High School-Central Mindanao Campus, Nangka, Baloi, Lanao del Norte</i> .
1.23	The Procuring Entity's Representative is <i>Mr. Franklin L. Salisid, Campus Director</i> .

Civil Engineer</p> <p>The Civil Engineer shall be a duly-licensed Civil Engineer with at least five (5) years of experience in similar and comparable projects.</p> <p>B. Electrical Engineer</p> <p>The Electrical Engineer must be a registered Electrical Engineer with at least five (5) years of experience in the design of lighting, power distribution and preferably knowledgeable in developments in emergent efficient lighting technologies and energy management.</p> <p>C. Foreman</p> <p>The Foreman must have at least five (5) years of experience in similar and comparable projects.</p> <p>D. Safety Officer</p> <p>The safety officer must have undergone the prescribed 40- hour Construction Safety and Health Training (COSH).</p> <p><i>NOTE: The names of the Key Personnel and their designation shall be filled out by winning contractor prior to contract signing.</i></p>
