### **Notes on the Bid Data Sheet**

This Section is intended to assist the Procuring Entity in providing the specific information in relation to corresponding clauses in the ITB, and has to be prepared for each specific procurement.

The PROCURING ENTITY should specify in the BDS information and requirements specific to the circumstances of the Procuring Entity, the processing of the procurement, the applicable rules regarding Bid price and currency, and the Bid evaluation criteria that will apply to the Bids. In preparing this Section, the following aspects should be checked:

- (a) Information that specifies and complements provisions of Section II. Instructions to Bidders must be incorporated.
- (b) Amendments and/or supplements, if any, to provisions of Section II. Instructions to Bidders as necessitated by the circumstances of the specific procurement, must also be incorporated.

##### C. CAD operators / Draftsmen

The CAD operators / Draftsmen must have at least two (2) year experience in CAD works, 3D Sketching and Rendering.

#### CONSTRUCTION PERSONNEL

##### A. Mechanical Engineer

The Mechanical Engineer must be a registered Mechanical Engineer with at least five (5) years' experience in HVAC and fire protection systems.

##### B. Electrical Engineer

The Electrical Engineer must be a registered Electrical Engineer with at least five (5) years of experience in the design of lighting, power distribution, communication systems.

##### C. Master Plumber

The Master Plumber must be a registered Master Plumber with at least five (5) years of experience in installation of commercial, industrial and water systems

##### D. Plumbers (minimum of 3 personnel)

The plumber must have at least five (5) years of experience in similar and comparable projects.

The welder must have at least five (5) years of experience in similar and
