5. **Award of Contract** shall be per item basis and shall be made to the lowest and responsive quotation which complies with the terms of reference stated herein.
6. Bidder must have at least **5 years of similar and/or relevant experience** related to the project.
7. Bidder must have the minimum personnel available with required qualification and experience data:
  - Architect;
  - Civil Engineer/Structural Engineer;
  - Electrical Engineer;
  - Mechanical Engineer; and
  - Sanitary Engineer/Master Plumber
