Invitation to Bid for the Installation Of Power Distribution Line And Communication Systems, Phase 1 (Re-Bidding)

- 1. The Philippine Science High School-Central Mindanao Campus, through the General Appropriation Act for CY 2014 (R.A. No. 10633)¹ Continuing Appropriations for CY 2015 intends to apply the sum of Four Million Two Hundred Forty Eight Thousand Seven Hundred Eighty Five Pesos & 83/100 (P4,248,785.83) being the Approved Budget for the Contract (ABC) to payments under the contract for CMC INFRA 15-10-001. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Philippine Science High School-Central Mindanao Campus* now invites bids for the following descriptions:
 - a. Supply, installation, and commissioning of 3-phase Power Distribution System for the campus which includes exposed and buried installation;
 - b. Energize the load center (1 set of three units transformer) to include necessary materials;
 - c. Supply and installation of primary line extension and distribution line to include electrical steel post, elevated platform, and necessary splicing, and any other necessary materials;
 - d. Construction of concrete pedestal ready for electrical post installation; and
 - e. Load balancing and correction (interconnection from the new power lines to the existing building connections) of existing building to include the necessary materials and labor for any rectification and/or modification works.
 - f. Provide the right materials and devices in accordance to the technical specifications specified by the technical working group;
 - g. Assist in the installation of devices into the most appropriate locations in all buildings in the campus particularly in the installation of wireless outdoor CPE Access (AP) and clients. Installation includes but not limited to the following: powering up and cabling of network devices such as switches, wireless extenders (AP), IP Phones; mounting of the access point and sector antenna on the tower; mounting of the CPE client devices into the most accessible locations from the access point in all buildings identified;
 - h. Assist in the configuration and link-up of wireless CPE devices to the network;

i. Make sure that all devices provided are fully functional (100% working) and in good condition with at least one (1) year warranty on all materials and devices after the installation.

Completion of the Works is required *in six* (6) *months*. The prospective bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, that contractors under Small A and Small B catergories without similar experience on the contract to be bid may be allowed to bid if the coswt of such contract is not more than fifty percent (50%) of the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from Philippine Science High School-Central Mindanao Campus and inspect the Bidding Documents at the address given below from 8:00am to 4:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 12-29, 2015 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos (P5,000.00)*, pursuant to the latest Guidelines issued by the GPPB.

It *may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later that the submission of their bids.

The *Philippine Science High School-Central Mindanao Campus* will hold a Pre-Bid Conference on October 17, 2015 (Saturday), 10:00AM at *OCD Boardroom, Philippine Science High School-Central Mindanao Campus,* which shall be open only to all interested parties *who have purchased the Bidding Documents.*

6. Bids must be delivered to the address below on or before *October 29, 2015, 10:00AM* at *Philippine Science High School-Central Mindanao Campus.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. Bidders' representatives who choose to attend in the Bid opening must secure authorization letter from their construction firm.

- 8. The *Philippine Science High School-Central Mindanao Campus* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
