REQUEST FOR EXPRESSION OF INTEREST FOR ARCHITECTURAL AND ENGINEERING DESIGN AND CONSULTING SERVICES FOR THE COMPLETION OF ROAD NETWORK/SITE DEVELOPMENT – PHASE 3

1. The *Philippine Science High School-Central Mindanao Campus*, through the *General Appropriation Act for CY 2015 (R.A. No. 10651)* intends to apply the sum of Five Hundred Twenty Five Thousand Pesos & 00/100 (P525,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CMC CONS 15-09-002. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Philippine Science High School-Central Mindanao Campus* now calls for the submission of eligibility documents for *the preparation of topographic map which shall include the location of buildings/structures and campus roads; scaled campus master development plan in 2D and 3D view showing the existing structures and the proposed structures development; prepare the design, drafting the plans and the detailed estimates of the followings:*
 - *Road concreting, to include parking areas and pathways;*
 - *Covered pathways;*
 - *Riprapping works in front of the two (2) dormitory buildings;*
 - *Symbolic landmark at the rotunda area;*
 - *Landscaping works; to include plants, flowers, trees, benches, nooks and gazebos;*
 - *School entrance development and landscaping works;*
 - *Completion of the drainage system;*
 - *Building directory and campus miniature;*
 - *And any other structures deemed necessary.*

Interested consultants must submit their eligibility documents on or before *October 7, 2015, 10:00AM* at PSHS-CMC, Nangka, Baloi, Lanao del Norte. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.

3. The BAC shall draw up the short list of consultants from those who have submitted *Expression of Interest* and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short

list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- Applicable experience of the consultant – 30%
 - Qualification of personnel who be assigned – 30%
 - Current workload relative to capacity – 40%
 - Passing rate – 80%
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.
- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)* procedure. The Procuring Entity shall apply the weights of seventy percent (70%) for the Technical Proposals and thirty percent (30%) for the Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
6. The contract shall be completed within *sixty (60) days*.
7. The Eligibility Screening form will be available at PSHS-CMC in Nangka, Baloi, Lanao del Norte upon submission of Letter of Intent and upon payment of non-refundable amount of Five Hundred Pesos only (P500.00) to the PSHS-CMC Cashier.
8. Bid documents will be available only to eligible bidders upon payment of non-refundable amount of Five Hundred Pesos (P500.00) to the PSHS-CMC Cashier.
9. The *Philippine Science High School-Central Mindanao Campus* reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
