CONTRACT AGREEMENT

THIS AGREEMENT made the 1st day of January 2023 between **PHILIPPINE SCIENCE HIGH SCHOOL – CENTRAL MINDANAO CAMPUS** of the Philippines (hereinafter called “the Entity”) of the one part and **DOUBLE TAP SECURITY AGENCY, INC.** of Pindugangan, Iligan City (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly to provide and assign staff to serve from January 1, 2023 to December 31, 2023 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FIVE MILLION FOUR HUNDRED SEVENTY-NINE THOUSAND EIGHT HUNDRED FIFTY-FIVE PESOS & 07/100 ONLY (Php 5,479,855.07)** (hereinafter called “the Contract Price”).

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - i. Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


